Lokmanya Tilak did not find it simple to work in England. At every deviation, he faced challenges. Also, he met with resistance and prejudice. Lokmanya Tilak was present in London it was the time of the postwar general election, and he grasped full advantage of the opportunities at that time.

Here the researcher has obtained one reference about Lokmanya Tilak had addressed various labour gatherings. We received one of the statements made by Lokmanya Tilak on 25 September 1918 in London. It was the International Brotherhood Welfare meeting, where Tilak made the statement, "The labour movement in India is still in its infancy, and even when it comes to the forefront, we will not be able to merely initiate the programme of the labour movement. Besides this, the researcher has observed that there were only a few people who realized the changing conditions in London. This act of Tilak was acknowledged gratefully with a promise that it would do everything in its capability to empower India to obtain Swaraj.To address mass meetings of workers from Glasgow, Edinburgh, Plymouth, and Southampton, Tilak used the platform of the Labour Party.

#### **Role of Newspapers**

Further, the researcher observed the beneficiary act done by Tilak when he was in London. Tilak took advantage of being in England and used the Labour Party's own newspapers to inform the people about the situation in India. Also, he talked about the ambitions of people and the suggestions of the Home Rule League.Further Tilak received huge response and support. The Herald published several articles to support Tilak and his various demands for the Indian Home Rule.

#### **Opposition faced by Lokmanya Tilak**

While performing this study, the researcher has gone through available literature. Then, it observed that several English officials who were returned from India had pain caused by the lashes received from Tilak's 'Kesari'. These officials made every attempt to stop Tilak. They got the sense that if they allow him to attend social events, then it was likely to meet English politicians and nobility. So, they tried to exclude Tilak from social events and gatherings.

#### Tilak's return journey to India

After completion of the Joint Parliamentary Committee work, on November 29, 1919, Tilak returned to India. Dr. Tilak D.J., Dr. Tilak G., (2019), "Lokmanya B. G. Tilak The Visionary", Tilak Maharashtra Vidyapeeth, Pune, 19.For every Indian, the day when Tilak returned was an occasion for quite a celebration. In his honour a whole nation arrived together. Thousands of people gathered in Bombay. People garlanded Tilak and greeted him.

Also, he was very close to the people. So, people were aware of his financial circumstances, and they know what the Chirol case had done to Lokmanya. Hence, they decided to raise money to mitigate the critical situation to some extent. Finally, people presented around 3 lakh funds, and we can say that such was the love and appreciation of the people towards Tilak.

After performing thorough research, we came to some of the interesting and less known facts about Lokmanya Tilak and his London visit. We came to know that he was a great thinker, and his visionary thoughts played a crucial role in attaining freedom.
